The news was first reported by journalist and podcaster Pablo Torre, and also announced by Onion CEO Ben Collins, who wrote on Bluesky, "With the help of the Sandy Hook families, *The Onion* has reached a long-awaited deal to take over InfoWars." Collins also said on Bluesky that Infowars' new creative director will be comedian Tim Heidecker.
